We would like to inform our valuable customers that none of the chemicals listed on the Current Candidate REACH SVHC List (Last Updated 15.01.2019; total 197 substances) are intentionally added in the manufacturing process as components of the mentioned above polypropylene grades. Therefore these polypropylene grades manufactured by «NPP Neftekhimia» LLC do not contain at levels greater than 0.1% (w/w) any substances listed in the Current Candidate List\*.

While we do not test each raw material we purchase, nor do we test our products for trace amounts of these substances, we do exercise good product stewardship practices and seek information concerning raw material composition from our suppliers. Based on information from our suppliers and knowledge of our process, we believe that our mentioned above products do not contain these substances.
